Street Sweeping by the Shire

My fellow Beolite Director Geoff Doyle and I were most appreciative of today's visit by the Mayor to Beolite Village. We were able to explain that there is considerable unhappiness and agitation felt by our residents that, unlike other Mansfield rate-paying residents, their streets are not covered by the Shire's regular street sweeping services.

On their behalf, Beolite pays their individual rates. These are currently more than \$80,000 each year. These rates are used to provide services elsewhere in Mansfield but not street sweeping at Beolite. To make matters worse, around 60% of residents are pensioners.

We strongly dispute the reasons given in your letter of 23 March 2020. 'OH&S, insurance and other reasons' have not prevented the Shire arranging the collection of residents garbage for 15 years! These standard excuses are just not valid in this situation.

Allowing street sweeping at Beolite Village would not be setting a precedent for the Shire. As a not-for-profit, tax exempt charity, Beolite is the only independent living retirement village in the Shire with Government endorsement. Beolite's directors have always given their time services voluntarily to ensure the success of a much need public facility. Surely the Shire can play its part - if only with street sweeping.

On behalf of Beolite Village and its 70 residents, we hereby lodge a formal objection to the decision and request that the matter be referred to Council for reconsideration and approval.
