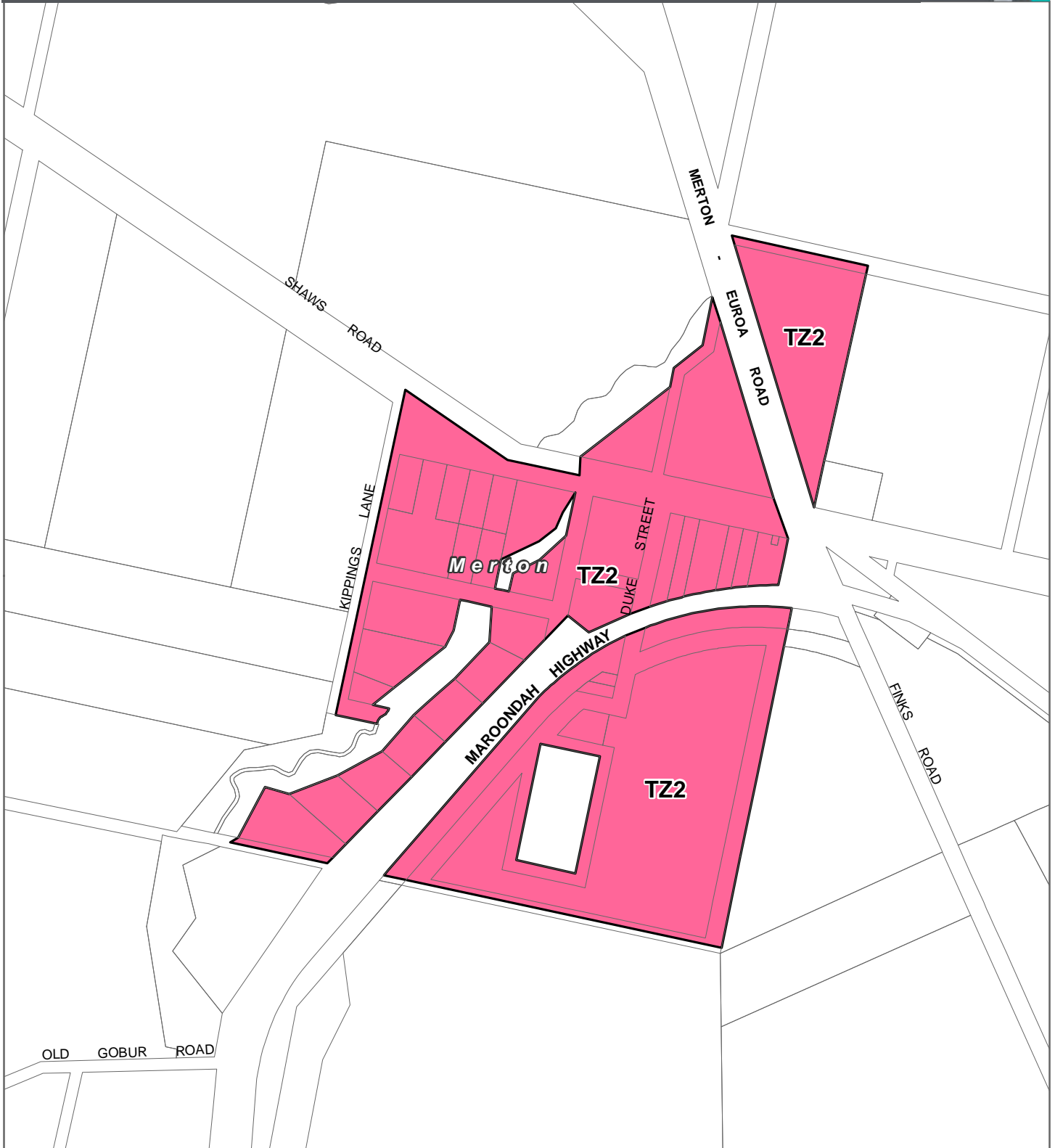

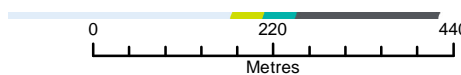

Part of Planning Scheme Map 5

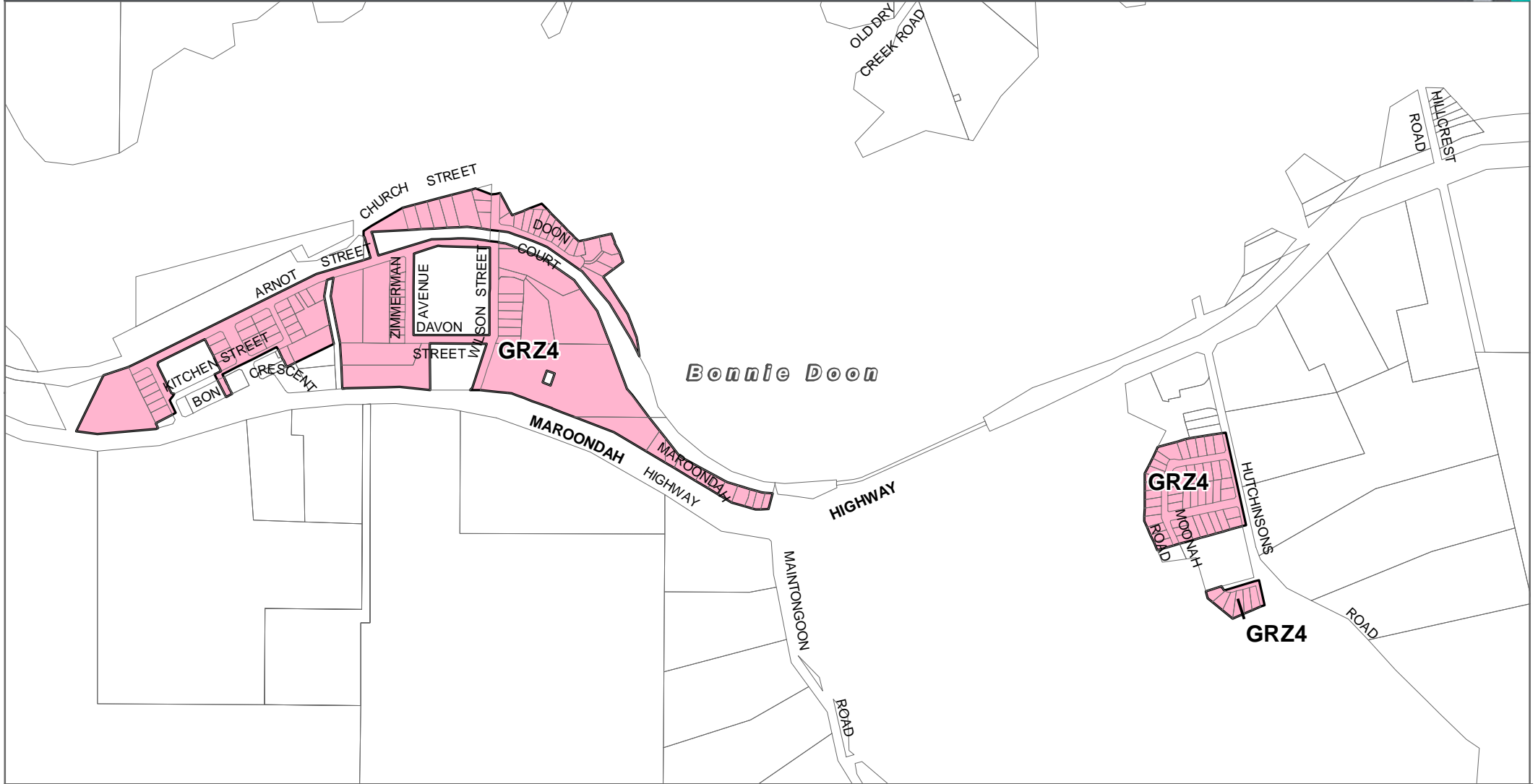

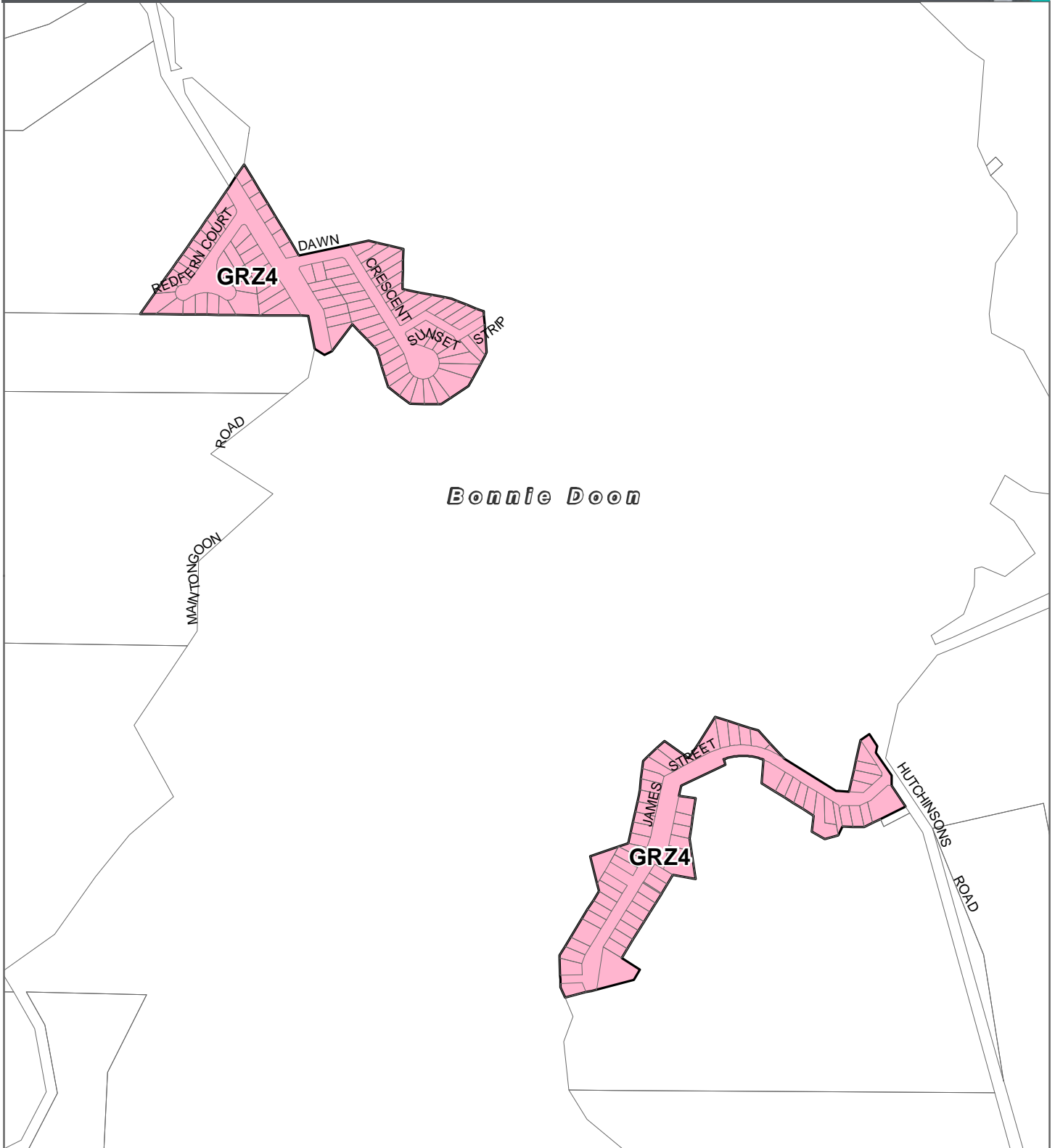

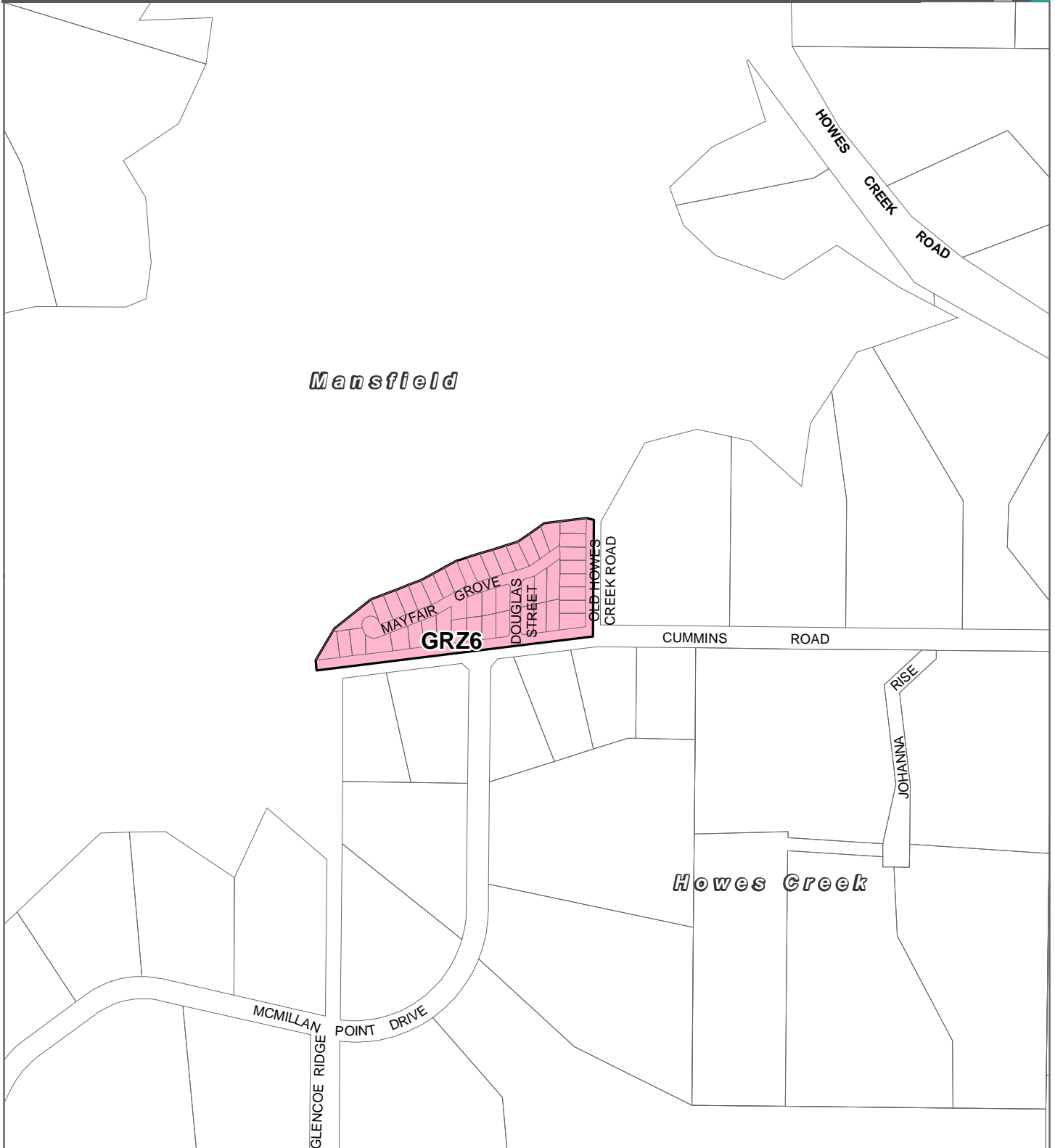

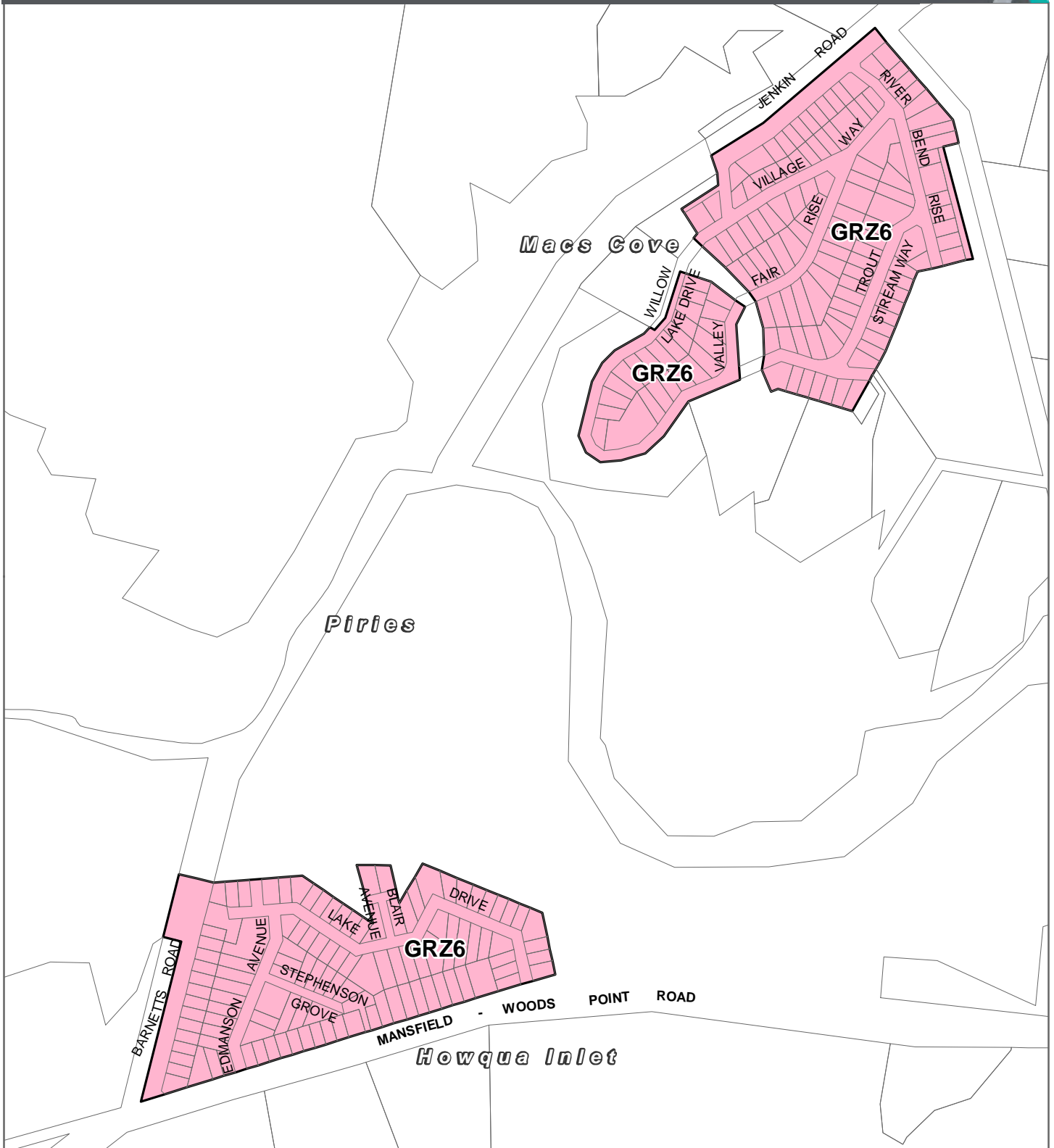

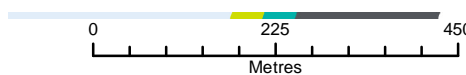

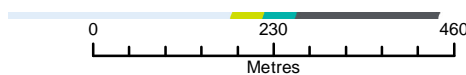
